## IMPORTANT NOTICE Official School Election Ballot Clinton-Glen Gardner School District

September 28, 2020

Dear Voter,

The Clinton - Glen Gardner Board of Education is a five-member elected body that adopts policy for the daily operation of schools and sees that school laws are properly explained, enforced, and observed. The Board consists of five members elected at-large from the Towns of Clinton and Glen Gardner.

It has come to my attention that the Official School Election for the Clinton-Glen Gardner School District Membership to the Board of Education -Glen Gardner- was omitted from the Glen Gardner Ballot in error. My office takes full responsibility for the omission of the contest on the Glen Gardner Ballots. The Clinton-Glen Gardner School and its School Board Administrator correctly filed the paperwork. It was an error on my part.

As it is a joint district and your voices have a right to be heard, I have worked closely with the Board of Elections and will be reissuing all Glen Gardner Borough residents' ballots. The reissued ballot will include the Clinton-Glen Gardner School District contest on the ballot.

A new ballot that includes the Clinton-Glen Gardner School District Membership to Board of Education will be mailed to all voters in Glen Gardner along with instructions beginning Tuesday, September 29, 2020. **If you have already returned your ballot and wish to vote in the Clinton-Glen Gardner School Election, the Board of Elections has implemented strict protocols for the acceptance of the second ballot.**

If you have not yet voted your ballot, please destroy the original ballot you have received and vote the corrected ballot when it is received. Ballots may be placed in the secure Drop Box located at the Municipal Building at 26 Main Street, Glen Gardner or returned directly to the Board of Elections, Historic Court House, 71 Main Street, Flemington.
